○ *Citizens' Nat'l Bank v. Scott*, 195 S.W.3d 94 (Tex. 2006) - Successfully obtained reversal at Texas Supreme Court of court of appeals opinion reversing successful trial court judgment in client's favor. On remand to the court of appeals, that court reversed its earlier ruling and affirmed the trial court judgment.
